

## ***Sweetwaters Coffee & Tea Exhibit – Prospectus***

***14850 N 87<sup>th</sup> Street, #110, Scottsdale, AZ***

***June 16,2022 – August 11, 2022***

*Scottsdale Artists League has been honored to exhibit our artwork exclusively at Sweetwaters Coffee & Tea. Crossroads are **Raintree Drive** and the **101**. Scottsdale Shops have anchor stores such as Walmart Superstore and Home Depot and Costco across the street of Northsight Blvd. Sweetwaters Coffee & Tea has a drive-thru and a café area which is the space our exhibit hangs.*

*Only 2-dimensional work will be accepted due to worry of damage to any 3-dimensional work by the patrons. No size limit because of the enormous wall size. Artwork must be framed, or gallery wrap with a minimum of 1.50” sides and finished on all sides. At this time only original artwork will be accepted. SAL standards require either screw-eyes or D-rings strung with wire. No saw-tooth hangers permitted. All work must be for sale. Two title cards must be filled out for each piece, and one securely attached to the back and another for the wall. Title cards will be available the day of the hanging.*

*Entry fee is \$20.00, and checks should be made out to Scottsdale Artists League. Sweetwaters Coffee & Tea require no donation; however, a 20% donation will be taken for Scottsdale Artists League for all sales. Should you sell a piece of artwork during the day of a promotion for a charity, 10% will be taken for that participating charity from the 20% donation to SAL.*

*The hang date is Thursday, June 16, 2022. Artwork, Hold Harmless and entry fees will be collected at **6:30 PM OUTSIDE**. Please bring up to 2 paintings. Two members will attend to the removal and hanging the new show. One member will go in and remove the paintings of the old show as if it does not interfere with customers. You may have to wait to retrieve your painting if a customer is sitting below your painting. Under no circumstances are you to enter the store and retrieve your painting. At 7:00 PM the two members working will go in and hang the new show. If you want to help hang the new show, you must wait until 7:00 PM. This is a great venue and currently we have had publicity and sold 6 paintings.*

*All sales transactions will be handled internally by Scottsdale Artists League. Any painting sold will be given to the buyer at the time of the money transaction. Sold paintings needs to be replaced with another painting of equal size. If the Artist cannot replace the painting, another Artist will be asked to fill that space.*

*Bring the Hold Harmless form, entry fee and 2 paintings with you June 16, 2022 at 6:30 pm. Take down and a new exhibit will be August 11,2022.*
