

# Sweetwaters Coffee & Tea Exhibit – Prospectus

14850 N. 87<sup>th</sup> St., #110, Scottsdale, AZ

January 25, 2024 through March 28, 2024

Scottsdale Artists League is honored to be the exclusive exhibitor of artwork at Sweetwaters Coffee & Tea. The Crossroads are **Raintree Drive** and the **101**. Scottsdale Shops have anchor stores such as Walmart Superstore, Home Depot, and Costco across the street of Northside Blvd. Sweetwaters Coffee & Tea has a drive-thru and a café area, which is the space our exhibit hangs. **This is a great venue – to date we have sold 30 paintings!!**

Only 2-dimensional work will be accepted due to the potential of accidental damage to 3-dimensional work by the patrons. Artwork (including frame), must be 48 inches or less on any side. *(Because the hangers we have available at Sweetwaters tighten with a thumbscrew, we do not recommend artists bring art weighing more than 10 pounds maximum. If in doubt, please display your piece at another SAL venue that has a more sturdy hanging system.)* Artwork must be framed or gallery-wrapped (minimum of 1.5" depth and finished on all sides). At this time only original artwork will be accepted (if your medium is photography or digital art, finished pieces must be professional quality). Show Chair and/or attending Board Members reserve the right to deny any piece of artwork deemed not up to the standards of SAL for any reason. All artwork must be for sale. Two title cards must be filled out for each piece of art (one securely attached to the back and the other for display on the wall next to the art). Title cards will be available the day of the hanging.

Entry fee is \$20.00. Checks should be made payable to Scottsdale Artists League. Sweetwaters Coffee & Tea does not charge a donation or sales commission; however, a 20% donation will be taken for Scottsdale Artists League for all sales. Should you sell a piece of artwork when Sweetwaters hosts a charity day, another 10% will be taken for their chosen charity.

The hang date for this next show is Thursday, January 25, 2024. Artwork, Hold Harmless, and \$20 entry fee will be collected at 6:15pm outside. At 6:30 we will go in and remove existing work and hang new pieces. (These guidelines may change depending on Sweetwaters' requests for how/when we hang the show, which changes with their seasonal occupancy fluctuations.) Sweetwaters has 24 hangers so we will draw names of who gets to hang a 2<sup>nd</sup> painting after we see how many SAL members are participating. When you arrive at 6:15, you will place your name in bucket and then once we go inside at 6:30, will know how many extra hangers we have and draw names accordingly. All sales transactions will be handled internally by Scottsdale Artists League. Any painting sold will be given to the buyer at the time of the monetary transaction. Sold paintings need to be replaced with another painting of the same size. If the Artist cannot replace the painting, another SAL Artist will be asked to fill the empty space.

Bring the Hold Harmless form, entry fee, and two paintings with you Thursday, January 25, 2024 at 6:15 pm. Take down and the replacement exhibit will be March 28, 2024.

Our SAL Treasurer, Donna Lewis, lives near Sweetwaters Coffee & Tea. She will collect monies for sold paintings and give the paintings to their new owners.
